### Workshop on "Dynamic Data Citation"

Riva del Garda, 20-21 April 2015

The Workshop is organized by the EU funded project "RDA Europe" (WP2: Fostering Innovation through European Stakeholder Engagement; Task T2.4: Computer Scientist, Data Technologist and existing e-Infrastructure Engagement).

The goal of this Workshop is to conduct a critical analysis of the findings and the recommendations produced so far by the RDA WG on "Data Citation".

To achieve this goal, a number of experts as well as representatives of large data organizations have been invited to attend the Workshop.

The expected outcome is a Report that will contain the main conclusions of the Workshop, that is, suggestions for (i) improving the technical solutions, and (ii) extending the proposed solutions to complex and volatile data structures. In addition, some real use cases will be delineated against which the applicability of the proposed solutions needs to be assessed.

### **RDA Working Group on Data Citation** (Chair: Andreas Rauber)

The RDA Working Group on Data Citation (WG-DC) aims to bring together experts to discuss issues, requirements, and solutions for efficiently citing subsets of (potentially highly dynamic) data. The goal is to assure that subsections of data can be uniquely identified in the face of data being added, deleted or otherwise modified in a database, across longer periods of time, even when data is being migrated from one DBMS to another. We want to develop concrete recommendations for enabling this form of data citation and demonstrate its feasibility via the deployment of prototypes within existing data centers. This WG concentrates on the technical aspects of data citation solutions, focusing on proof of concept and prototype implementations. It will collaborate with other RGA working groups on PIDs and other topics under the umbrella of the Interest Group on Data Publication.
